## **MEMORANDUM**

Sub: Streamlining of Clerical cadres – reg.

As per Ministry's letter dated 17.03.2011 on streamlining the clerical cadres as well as its pay scales and based on the recommendation of the DPC held on 07.02.2014, Chairman has decided to remove the post of Junior Section Officer in PB.2 Rs.9300-34800 + GP Rs.4200 from the existing categories and to accommodate all the incumbents in the cadre of Junior Section Officers to the post of Section Officer in PB.2 Rs.9300-34800 + GP Rs.4600. It is also decided to protect the seniority/pay fixation of existing incumbents in the cadre of Section Officers.
