MEMORANDUM

Sub: Promotion and posting – reg.

In compliance of the Judgment of Hon'ble High Court of Kerala dated 14.09.2015 in WP(C) No.18389 of 2006 (L), the Departmental Promotion Committee meeting held on 9.12.2015 recommended to grant notional promotion to Smt.Sreelatha S. as EDP Assistant with effect from 29.12.2000 in the scale of pay of Rs.5500-175-9000 (pre-revised) on ad-hoc basis and as EDP Assistant with effect 14.01.2005 in the scale of pay Rs.5500-175-9000 (pre-revised) on regular basis. The Departmental Promotion Committee also recommended to grant notional promotion to Smt.Sreelatha S. as EDP Officer with effect from 22.04.2008 in the PB-2 Pay Band of Rs.9300-34800 + GP Rs.4600/-. Based on the recommendations of the Departmental Promotion Committee, Smt.Sreelatha S. is notionally promoted as EDP Assistant with effect from 29.12.2000 in the scale of pay Rs.5500-175-9000 (pre-revised) on ad-hoc basis and as EDP Assistant on regular basis in the scale of pay Rs.5500-175-9000 (pre-revised) with effect from 14.01.2005 and to the post of EDP Officer with effect from 22.04.2008 in the PB-2 Pay Band of Rs.9300-34800 + GP Rs.4600/-.

As Smt.Sreelatha S. was granted promotion to the post of EDP Officer with effect from 22.04.2008, the 2<sup>nd</sup> financial upgradation granted to her with effect from 07.05.2012 under MACP scheme stands cancelled.

On promotion as EDP Officer Smt.Sreelatha S is posted to Regional Office, Spices Board, Guwahati. The actual promotion of Smt.Sreelatha S. as EDP Officer will take effect from the date on which she reports for duty at Regional Office, Spices Board, Guwahati.

Smt.Sreelatha S. will not be entitled to any arrears of pay and allowances in the promoted posts in view of the direction of the Hon'ble High Court of Kerala in the Judgment dated 14.09.2015.
